## **Design Phase**

The design phase includes three rounds of revisions. Designs must be approved within 30 days from the date designs are presented. Delays in approval may cause additional work, adding cost to the project, which we will estimate separately and in addition to the costs outlined in this proposal. Only after designs are approved will exhibit-E begin programming of the final design. Failure to provide approval, and sign-off of designs, may result in schedule delays depending on exhibit-E workflow.

# **Programming Phase**

Once the design phase is complete we will provide a schedule for the start of the Programming phase. Programming usually takes six to eight weeks. Please note, once the design is approved and programming has begun, changes to the design and functionality of the website will result in additional costs.

# Q/A Phase (Quality Assurance)

Once the programming of your website is complete, it will transition into the Q/A phase, where you will have the ability to populate your website content from the administration page of the website. During this phase you will be able to examine the site for any possible inconsistencies of design, navigation or programming issues. Note: Any issues not resolved in the Q/A phase will incur maintenance costs once the site is live. All proofreading, text and content revisions will be the responsibility of the 303 Gallery.
